MOBILE DEPOSIT

Postal Family Federal Credit Union offers Mobile Deposit. Once you are registered on CU Connect, just go to the App Store on your phone and select the Postal Family FCU app. Download it and you're ready to go. When you sign up, you'll receive an email response, approving your acceptance. Please read the disclosure and note that it may take up to 24 hours for the funds to be available. Endorse the back of your check, write "For Mobile Deposit only to PFFCU," and date it. Take a photo of the check (front and back), and email it to us as directed. It's that easy!

IRA REMINDER

The 2019 tax filing deadline is Wednesday, July 15, 2020, to contribute to your Traditional or Roth IRA. The maximum IRA contribution for 2019 is \$5,500; it's \$6,500 if you are 50 or older. If you have tax-related questions, please consult your tax advisor.
